

2010 SACKETT FAMILY REUNION QUESTIONS AND ANSWERS

Part 2

There has been some confusion on earlier correspondences that I wrote that needs clarification. I have added some new information as well. So I hope to answer questions you may have about the 2010 Sackett Family Reunion.

1. Why are there a \$25 registration and a \$100 activities charge ?

These charges are the expenses of the reunion that include tours, transportation, gifts, and 3 meals (barbeque lunch, picnic lunch, and dinner).

2. What about those people who are on a limited income and can't afford all this ?

Anyone over the age of 65 has FREE registration costs. I believe that the older you are the more valuable you are and we really want you to join us at the reunion.

3. Where does the money come from ?

Some funds have been passed on to me from the previous reunions. Some comes from donations. The reunion committee should at least twice a year have a fund raiser. I don't think a fund raiser has been done before.

4. Can we pick and choose what we want to do for activities ?

The simple answer is YES, the \$100 per person activities charge is if you plan to participate in everything we will be doing. There will be an itemized list of activities we plan to have with the cost of each and you check or circle those you want to participate in and pay for only those you want too.

For example; we will be visiting the Portland Genealogical Forum. Cost is \$5 per person to attend plus \$15 per person for transportation to the Forum and back. \$20 total would be the cost you would have to pay if that was the only thing you wanted to do. If you have your own transportation the cost is \$5.

5. Do we need to pay by March 31, 2010 ?

No, you do not need to make any payments until a later date. You do need to request a registration form from me by email with your mailing address.

6. Why are registration forms being mailed out ?

The registration form is being mailed out with the itemized cost sheet, motel accommodations, information on the different things to see and do while you are here, a self addressed stamped envelope to mail the registration and activities form back to me. It is important I get a count of how many are attending so the faster I can get your request for a registration form, the faster I can get things reserved and ordered. 7. What forms of payment are acceptable ?

You can pay to me by personal check or online Pay Pal. I can also accept prepaid Visa card online transfers through Meta Bank.

8. I need each family that attends the reunion to bring, a wrapped gift from their home town, state, country or providence for gift exchange. Price for gift is not to exceed \$5.00 or \$6.00 with tax.
